POSITION SUMMARY:

Our board-certified women's health nurse practitioner (BC-WHNP) or certified nurse midwife (CNM) provides professional nursing care to assigned patients in our outpatient facility. Working closely as a member of the interprofessional team to ensure the highest standard of patient and customer care by offering comprehensive women's services, including obstetrics and gynecology. The BC-WHNP or CNM is a specialist whose focus is the care of women across the lifespan including, but not limited to, well-woman care, health education, contraceptive counseling and prenatal care. The BC-WHNP or CNM practices under the rules and regulations of the Ohio Board of Nursing. Utilizing evidence to drive clinical decisions and practice related to individual and population health. The NP or CNM participates in continuous quality improvement initiatives and assumes responsibility for their professional development.

SUMMARY OF RESPONSIBILITIES:

- Always maintains strict patient confidentiality.
- Completes patient history and physical.
- Documents all patient care provided according to policy and Standard of Care Agreement.
- Formulates and directs plan of care for the patient according to Standard of Care Agreement.
- Refers to other Providers as needed.
- Prescribes medications in accordance with Ohio revised code and Ohio Administrative Code and Formulary provided by the Advanced Practice Nursing laws.
- Complies with State Advanced Practice Nursing Guidelines/Law on Practicing Medicine.
- Directs patient education for health education, maintenance, emotional and physical needs.
- Utilizes supplies in a cost-effective manner.
- Demonstrates effective communication skills.
- Establishes and maintains professional working relationship with other members of the health care team and staff.
- Participates in planning and problem solving.
- Participates in continuing education and professional growth.
- Attends all required staff meetings.
- Maintains knowledge of, and complies with, personnel and medical, policies and procedures.
- Assists other team members.
- Serves as a role model for staff.
- Adheres to the standards and policies of the Organizational Privacy/Security and Compliance Programs, including the duty to comply with applicable laws and regulations (HIPAA. OSHA, OIG, guidelines,

- other State and Federal laws). This also includes reporting to the Board of Directors, Compliance Officer, Manager, and suggestion box, any suspected unethical, fraudulent, or unlawful acts or practices.
- Puts forth an effort to promote and participate in activities that benefit the organization including fundraising and community organization.
- Performs other related duties as assigned.
